1. Duly accomplished **Affidavit of Lack of Legal Capacity of Minor Child** and one (1) photocopy;
2. Original valid **Philippine passport** and one (1) photocopy of its data page (*Original to be returned to applicant after verification*);
3. Original and one (1) photocopy of **Einbürgerungszusicherung** wherein the name of the minor child is included. (*Original to be returned to applicant*);
4. Certification and Affidavit to be released after five (5) working days together with the Principal/Parent;
5. Fees:       Notarial of Affidavit                               -       Euro 22,50  
                  Certificate of Renunciation                     -       Euro 22,50  
                  (**CASH PAYMENT ONLY** for walk in applicants)

**APPLYING VIA MAIL**

*For applicants who cannot appear in person at the Philippine Embassy in Berlin, they may send the above-mentioned requirements by mail (except the fees) provided that the **Affidavit** is signed by a German Notar and authenticated by the State Judicial President (Landgericht) where the Notar is registered.*
