

## VISA REQUIREMENTS

- **FOREIGN SPOUSES OF FILIPINO NATIONALS**
- **FOREIGN MINOR CHILDREN, AND FOREIGN CHILDREN WITH SPECIAL NEEDS REGARDLESS OF AGE, OF FILIPINO NATIONALS**
- **FOREIGN PARENTS OF MINOR FILIPINO CHILDREN AND OF FILIPINO CHILDREN WITH SPECIAL NEEDS REGARDLESS OF AGE**

1. Duly accomplished FA Form No. 2

2. Original machine-readable passport with a minimum validity of six (6) months beyond the intended stay in the Philippines

3. Photocopy of passport's data page

4. Printed airline booking or itinerary of travel showing dates of arrival and departure from the Philippines

5. Proof of relationship (original and one photocopy)

a. Marriage Certificate (Philippine Bureau of Immigration-approved documents)

i. **PSA/NSO-issued**

ii. **Certified-True-Copy of Report of Marriage** (*Consularization of document will apply*)

iii. **Embassy Authenticated Auszug aus dem Heiratseintrag (Formule B)** (*Consularization of document will apply*)

b. PSA-issued Birth Certificate of Minor Child

6. Proof of citizenship of Filipino spouse/child (e.g. current Philippine passport)

7. Documents to establish that the Filipino spouse/minor child will be travelling with the applicant or is/are currently in the Philippines (e.g. airline ticket or itinerary showing names of passengers or certification from the local government [Barangay] officials where they reside.)

8. Proof of financial capacity (most recent bank statement and/or if employed, latest three (3) month payroll slip (*Lohnabrechnung*))

9. Proof of payment for the visa fee (**27,00 Euro**) transferred to the following bank details:

10. Return envelope preferably from reputable courier service providers (DHL, UPS or DPD) or self-addressed envelope with 4,05 Euro postage stamps (*Einschreiben*)

### IMPORTANT:

VISA APPLICANTS ARE STRONGLY ADVISED TO FINALIZE THEIR FLIGHT BOOKING ONLY AFTER THE VISA IS GRANTED. THE EMBASSY WILL NOT HASTEN THE VISA PROCESSING TO ACCOMMODATE THE APPLICANT'S FLIGHT SCHEDULE.

PROCESSING TIME IS FROM FIVE (5) TO TEN (10) WORKING DAYS.

PLEASE NOTE THAT NO REFUND OF THE VISA APPLICATION FEE WILL BE MADE FOR WHATEVER REASON.
