*Nationals of countries listed below may enter the Philippines without a visa for an initial stay of **30 days***

1) Passport holders of Brazil and Israel are given 59-day stay based on existing agreements.

2) Indian nationals may be granted a visa-free entry for an initial stay not exceeding 14 days, provided, that they possess:

- Unexpired US, Japanese, Australian, Canadian, Schengen, Singapore or UK visa or permanent residence permit;
- A national passport valid at least six (6) months beyond the contemplated stay;
- Return or onward ticket to the next country of destination;
- No Bureau of Immigration (BI), National Intelligence Coordinating Agency (NICA), and the International Police (Interpol) derogatory record.

Note: The 14-day visa-free entry may be extended by an additional seven (7) days for a maximum 21 days.

3) Under Foreign Service Circular (FSC) No. 112-11, the following may enter the Philippines for an initial stay not exceeding seven (7) days if they possess a return or onward ticket:

- Holders of Hong Kong British National Overseas (BNO) passports
- Holders of Macau-Portuguese passports, and
- Mainland Chinese nationals coming for tourism with unexpired Australian, Canadian, Japanese, Schengen or US visa.

4) Under FSC 122-11, holders of Hong Kong Special Administrative Region (SAR) and Macau-SAR passports may enter the Philippines for an initial stay of fourteen (14) days, provided, that they possess a return or onward ticket.

5) Under Operations Order No. SBM-2015-018, MECO ETA holders may enter the Philippines for an initial stay of 30 days.
